Rationale, History, Objective	The Paulding County School District continues to show an increase in student growth but not at the rate the district experienced during the past decade. The voters of Paulding County approved a \$130,000,000 bond referendum in 2006 that enabled the District to construct 5 new elementary schools and 2 new middle schools. We also constructed additions to 2 elementary schools, 3 middle schools and all 5 high schools. This allowed the district to move our students from temporary mobile and modular classrooms into a regular classroom environment. In 2013, the Paulding County School District began a program to fund intensive renovations and modifications to our older schools. The district has several schools that were built in 1954. These older facilities have been modernized with more efficient lighting and HVAC systems as well as cosmetic improvements. The District will continue with a renovation and modification program. It is the District's goal to provide the students of the Paulding County School District a safe and comfortable learning environment that will allow them to become educated adults to meet the challenges they will encounter.
