Dear Parents of Students with Disabilities,

The COVID-19 outbreak has caused unprecedented change in the state of Georgia. With a commitment to keep the health, safety and well-being of students and staff the highest priority, Paulding County School District is closed Monday, March 16 through Friday, March 27. The district plans to reopen on Monday, March 30.

Special Education Services through Digital Learning

The district will begin Digital Learning Days on Tuesday, March 17. All special education students will have access to special education services provided through digital learning opportunities from special education teachers, speech language pathologists, occupational and physical therapists, and other special education staff. The special education teachers and service providers have established office hours each day. This provides the time for our staff to check in with students and for parents to reach out to staff. If you have any questions related to any special education digital learning activities, please email your child's case manager.

IEP Meetings and Eligibility Meetings

The district plans to hold all IEP and Eligibility meetings during the district closure.

Please keep any previously scheduled meeting on your calendar.

GADOE-Special Education and Student Supports Department recommends that school districts utilize virtual meetings. We plan to offer two options for virtual meetings.

- 1) We can provide a video conference option for all meetings. We will use the ZOOM video conferencing platform (computer, tablet, or smart phone) to conduct all meetings. There is no cost for using this platform. Please see the attached pages with information on ZOOM video conferencing or [click here](#).
- 2) We can provide a conference call option for all meetings. Case managers will send you a phone number with an access code. Call in from any phone and hold your meeting.

Staff from your child's school will contact you to confirm the meeting and email you pertinent information for the virtual meeting. Our goal is to respect your time and to provide meaningful parent participation in a timely manner. There could be a substantial delay if a meeting is cancelled and rescheduled once we are back in school. If you have any questions related to a meeting scheduled between March 16 and March 27, please email your child's case manager.

Excerpt from OSERS (Federal Office of Special Education and Rehabilitative Services)

Question: Is an LEA required to continue to provide a free appropriate public education (FAPE) to students with disabilities during a school closure caused by a COVID-19 outbreak?

Answer: The IDEA, Section 504, and Title II of the ADA do not specifically address a situation in which elementary and secondary schools are closed for an extended period of time (generally more than 10 consecutive days) because of exceptional circumstances, such as an outbreak of a particular disease. If an LEA closes its schools to slow or stop the spread of COVID-19, and does not provide any educational services to the general student population, then an LEA would not be required to provide services to students with disabilities during that same period of time. Once school resumes, the LEA must make every effort to provide special education and related services to the child in accordance with the child's individualized education program (IEP) or, for students entitled to FAPE under Section 504, consistent with a plan developed to meet the requirements of Section 504. The Department understands there may be exceptional circumstances that could affect how a particular service is provided. ... If an LEA continues to provide educational opportunities to the general student population during a school closure, the school must ensure that students with disabilities also have equal access to the same opportunities, including the provision of FAPE. (34 CFR §§ 104.4, 104.33 (Section 504) and 28 CFR § 35.130 (Title II of the ADA)). SEAs, LEAs, and schools must ensure that, to the greatest extent possible, each student with a disability can be provided the special education and related services identified in the student's IEP developed under IDEA, or a plan developed under Section 504. ZOOM Joining a Meeting

Overview

In this article, we will discuss how to join an instant meeting through an email invite, an instant messaging invite, from the browser, from the Zoom desktop and mobile application, from a landline or mobile phone, and with a H.323 or SIP device.

Before joining a Zoom meeting on a computer or mobile device, you can download the Zoom app from [our Download Center](#). Otherwise, you will be prompted to download and install Zoom when you click a join link.

You can also [join a test meeting](#) to familiarize yourself with Zoom.

Prerequisites

- Each meeting has a unique 9, 10, or 11-digit number called a [meeting ID](#) that will be required to join a Zoom meeting
- If you are joining via telephone, you will need the [teleconferencing number](#) provided in the invite.



1. Open the Zoom desktop client.
2. Join a meeting using one of these methods:

- Click **Join a Meeting** if you want to join without signing in.


