Deaf/Hard of Hearing

A child who is deaf or hard of hearing is one who exhibits a hearing loss that, whether permanent or fluctuating, interferes with the acquisition or maintenance of auditory skills necessary for the normal development of speech, language, and academic achievement and, therefore, adversely affects a child's educational performance.

A child who is deaf can be characterized by the absence of enough measurable hearing (usually a pure tone average of 66-90+ decibels American National Standards Institute without amplification) such that the primary sensory input for communication may be other than the auditory channel.

A child who is hard of hearing can be characterized by the absence of enough measurable hearing (usually a pure tone average range of 30-65 decibels American National Standards Institute without amplification) that the ability to communicate is adversely affected; however, the child who is hard of hearing typically relies upon the auditory channel as the primary sensory input for communication.

Traumatic Brain Injury

Traumatic Brain Injury (TBI) refers to an acquired injury to the brain caused by an external physical force, resulting in total or partial functional disability or psychosocial impairment, or both, that adversely affects the child's educational performance. The term applies to open or closed head injuries resulting in impairments which are immediate or delayed in one or more areas, such as cognition, language, memory, attention, reasoning, abstract thinking, judgment, problem solving, sensory, perceptual and motor abilities, psychosocial behavior, physical functions, speech and information processing. The term does not apply to brain injuries that are congenital or degenerative in nature, brain injuries induced by birth trauma.

Significant Developmental Delay

The term significant developmental delay refers to a delay in a child's development in adaptive behavior, cognition, communication, motor development or emotional development to the extent that, if not provided with special intervention, the delay may adversely affect a child's educational performance in age-appropriate activities. The term does not apply to children who are experiencing a slight or temporary lag in one or more areas of development, or a delay which is primarily due to environmental, cultural, or economic disadvantage or lack of experience in age appropriate activities. Initial eligibility must be established, and an IEP in place, on or before the child's seventh birthday. The SDD eligibility may be used for children from ages three through nine (the end of the school year in which the child turns nine).

Emotional and Behavioral Disorder

An Emotional and Behavioral Disorder is a condition in which a student exhibits one or more specific emotional and/or behavioral difficulties over a period of time and to a marked degree, which adversely affects educational performance. A student with an Emotional and Behavior Disorder exhibits one or more of the following emotionally based characteristics:

An inability to build or maintain satisfactory interpersonal relationships with peers and/or teachers.

An inability to learn which cannot be adequately explained by intellectual, sensory, or health factors.

Consistent or chronic inappropriate type of behavior or feelings under normal conditions.

Displayed pervasive mood of unhappiness or depression.

Displayed tendency to develop physical symptoms, pains or unreasonable fears associated with personal or school

NOW COMP Waiver BEE

Our final Waiver Bee of the 2016-2017 school year will be on March 14th from 5:30--7:30 at the Board of Education Building (3236 Atlanta Highway, Dallas, GA). This is an opportunity to have Parent to Parent of Georgia representatives help parents complete the application for a NOW/Comp Waiver.

The NOW/Comp (also known as Medicaid or DBHDD) waiver is what provides services to individuals with intellectual/developmental disabilities after high school. There is a waiting list for waiver services so we recommend getting the application completed many years before your student exits high school.

Because of the personalized nature of this service, we have only 9 spots available for parents who are interested in participating. Please respond as soon as possible if you are interested.
