



# Summer School 2019



Paulding County School District's 2018– 2019 summer school provides an opportunity for all currently enrolled Paulding County School District students in grades 8 – 12 to recover high school level credits attempted throughout the school year. Opportunities for new credit are available on a limited basis. All courses are offered in an online format via A+ and PLATO software with our teachers/facilitators.

All grades for summer school will be available to the districted school once the summer school session as ended.

### Registration:

- Transportation is not provided.
- Registration must be approved and completed by the districted school counselor.
- \$275.00 per ½ credit; \$550 per full credit in the form of credit card, debit card, or personal checks.
- Payment is required at the time of registration.
- Refunds are provided prior to June 6, 2019.
- All registrations after May 30<sup>th</sup> will occur at NHEC.

Virtual Learning: Students have the option to request our virtual learning model. Virtual learning students will have full access to NHEC teachers/facilitators. Student approval for the virtual learning model will only be granted through NHEC. Approval may be given after attending the first full week of the summer school session. Approved students may work from home while completing assignments. All summative assessments must be completed at the NHEC facility.

### NCAA Eligibility:

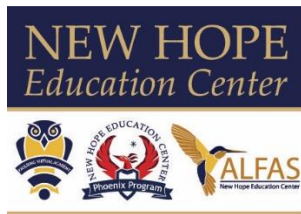

# Summer School 2019



## FAQ:

1. How long is summer school?
  - 3.5 weeks from June 6<sup>th</sup> – June 28<sup>th</sup>
2. How many sessions?
  - Summer school is every day except for weekends.
  - We have a session for students requesting 0.5 credits.
    - i. 7:30 a.m. – 11:30 a.m.
  - We have a session for students requesting 1.0 credits or more.
    - i. 7:30 a.m. – 3:30 p.m.
3. Can students take new credit?
  - On a very limited basis. Counselors must communicate with NHEC prior to registration.
4. What about NCAA eligibility for student athletes?
  - We are able to provide NCAA classes during the summer. Students in this situation must complete the entire course as a new credit and cannot end prior to the last day of summer school.
5. What about virtual status?
  - Students are able to achieve virtual status after June 13<sup>th</sup>. Virtual status will be determined at NHEC and is based upon the student meeting two criteria: on pace progress, passing the course.
6. How many classes can a student take?
  - Students may register for up to 1.0 credit at a time. If a student has completed the course by June 18, the student may register for a new class. The additional course registration will occur at NHEC.
7. What about End of Course (EOC) testing?
  - Testing for EOC course are on July 1st through July 3<sup>rd</sup>. The specifics about which tests will occur on which day will be provided once classes have officially started. NHEC requires the time to determine how many students require testing and of which type.
  - NHEC will provide testing for students that participate the NHEC summer school.
8. When are the grades sent to the school?
  - Because NHEC is a PCSD program, grades are instantly available to the schools.
9. Are teachers available to help students?
  - Yes, that feature is one of the things that makes PCSD's summer school unique. We have teachers that are specific to the subject ready to reteach and support students with their coursework.
10. Is there anything else that I need to know?
  - Summer school is a relatively brief but concentrated school semester. Due to the length of summer school students should expect to spend 4-8 hours per day working on their courses. We have had great success and our students score well on the EOC. Over 90% of our students successfully complete summer school each year. The student maintains control of their course, but we are here to help in any manner that a student requires.
