Proposed Timeline

January, 2019 Community Conversations

February, 2019 Undertake facility needs assessment/facility planning

March, 2019 Develop project costs/cash flow projections/bond requirements

Finalize project prioritization, Capital Outlay funding planning

April, 2019 Share draft project needs list with Board of Education

June, 2019 Board Approval – Finalize project needs list

Distribute first drafts of SPLOST Referendum

July, 2019 School Board to adopt Referendum Resolution

Finalize and implement community awareness efforts

August, 2019 Notice to Board of Elections

October, 2019 Publish Notice of Election in local newspaper

November, 2019 VOTE – Education SPLOST Referendum





Background

Georgia Department of Health Online Analytical Statistical Information System (OASIS) live birth data






Population Change 2000-2015







INCREASE TO POPULATION (2015-2040)






Paulding Census Bureau Residential Building Permits (2001-2017)








High School Enrollment vs. Capacity 2017-18








High School Enrollment vs. Capacity 2027-28








Middle School Enrollment vs. Capacity 2017-18
