

## Dual Enrollment/Move on When Ready



Paulding County School District students most often attend Chattahoochee Technical College, Georgia Highlands, Kennesaw State University and the University of West Georgia due to location. Please know that students may take advantage of other postsecondary schools throughout the state. Always make inquiries of your school counselor, if you have any questions.

Below are deadlines as well as admissions requirements for the above institutions:

Test scores, application, and MOWR student participation agreement must be submitted **by 4:30 p.m.** on the applicable deadlines below:

**Spring Semester 2017** (January–May 2017): Friday, **November 18, 2016**

**Summer Semester 2017** (June–August 2017): Friday, **March 24, 2017**

**Fall Semester 2017** (August–December 2017): Friday, **May 19, 2017**

Qualifying test scores to enroll in MOWR (for academic courses\*) are as follows:

SAT (taken before March 1, 2016)	Not Required	460	440

If you have taken the SAT, then go to [www.collegeboard.org](http://www.collegeboard.org), log into your account, and print a copy of your score report (or take a screen shot) and scan/email it to [MOWR@chattahoocheetech.edu](mailto:MOWR@chattahoocheetech.edu).

If you have taken the ACT, then go to [www.actstudent.org](http://www.actstudent.org), log into your account, and print a copy of your score report (or take a screen shot) and scan/email it to [MOWR@chattahoocheetech.edu](mailto:MOWR@chattahoocheetech.edu).

If you have not taken the SAT and/or ACT or your scores do not meet the minimum requirements, then you will be required to take our college Accuplacer placement test.

### ACCUPLACER TESTING INFORMATION

- There is no charge for the Accuplacer test for students wishing to pursue Move On When Ready (MOWR).
- Testing days/times vary per campus and can be found [HERE](#).
- Students must present their photo ID at the time of the test, and identify themselves to the testing administrator as a high school student testing for MOWR.

- Students must know/bring their Social Security Number, as this will be used to issue them a Chattahoochee Tech student ID number (900#).
- Students must select that they are “testing for MOWR” on the Testing Registration Form (completed at the time of the test) to ensure that the testing fee is waived.
- Students are allotted two testing attempts to meet minimum scores per enrollment term.
- The Accuplacer test is not timed but typically takes 2-3 hours to complete all sections.
- CTC does not allow outside calculators; the test will offer one if needed to solve a problem.
- Test scores will be received immediately upon completion of the test.

### Admission Requirements for MOWR

**NOTE: High school students who are applying for MOWR should NOT use the “Apply Now” button to the right. Instead, to apply for MOWR, please follow the instructions BELOW.**

#### Admission Requirements

- Student must be enrolled in an eligible public or private high school or home school program in Georgia.
- Student must be a minimum of 14 years of age prior to the first day of their college enrollment term.
- Student must have completed at least their first semester of 9th grade at their high school/home school.
- Minimum SAT, ACT, or Accuplacer test scores. (Requirements can be found [HERE](#).)
- **Move on When Ready** ONLINE admissions application.
- **Move on When Ready** Student Participation Agreement (must be signed by high school counselor and parent/guardian).
- Qualifying test scores, MOWR online admissions application, and MOWR student participation agreement must be submitted to the college prior to the applicable deadline for the semester the student is enrolling. MOWR Admissions Deadlines are listed [HERE](#).

#### Enrollment Steps on Website:

**Step 1:** [APPLY HERE](#) to complete the online MOWR admissions application. This application will require that you attach your test scores prior to submission. If you have not taken the SAT and/or ACT or your scores do not meet the minimum requirements listed [HERE](#) to enroll in MOWR, then you must take the Accuplacer test (information for taking the Accuplacer test can be found [HERE](#)).

**Step 2:** Meet with your high school counselor/home school administrator and parent/guardian to complete the Move On When Ready student participation agreement below:

**Step 3:** Scan and email completed MOWR student participation agreement to [MOWR@chattahoocheetech.edu](mailto:MOWR@chattahoocheetech.edu).

**Step 4:** Receive acceptance letter/email.

**Step 5:** Attend orientation and registration session with MOWR college advisor (information for scheduling will be included in acceptance letter/email) and register for classes

**Step 6:** Complete MOWR financial aid application.

- Students attending a **public or private high school** should log into [www.GAfutures.org](http://www.GAfutures.org) and complete the MOWR (financial aid) application online. If you do not have a GAfutures account, then you will need to create one.

## Move on When Ready



### Admissions Requirements

The Move On When Ready (MOWR) Program is designed for high school students who are capable of entering college while still completing high school coursework and requirements. Students must have approval from their high school counselor **and** their parents. Please seek approval from your high school counselor before beginning the application process. **It is important to note that the MOWR program covers tuition, most fees, and books. Some fees, such as a Science lab fee or online course fee, are the responsibility of the student.**

### **IMPORTANT ANNOUNCEMENT: College Board SAT Redesign – March 2016**

In March 2016, the College Board redesigned the national SAT test. The highest scores on either the redesigned SAT or the old SAT will be used to determine admissibility to Georgia Highlands College. In order to equate the redesigned scores to the MOWR minimum (verbal/critical reading, math and the combined (total) score requirements, as detailed for each grade level) Georgia Highlands College will use the SAT Score Converter tool provided by the College Board at (<https://collegereadiness.collegeboard.org/sat/scores/understanding-scores/sat-score-converter>). #### Admissions Requirements

**Notice:** Students under the age of 15 must have a SAT combined score of 1500 or ACT composite score of 33 to participate in the MOWR program.

#### Steps to Enrollment

All materials must be submitted by the applicable [deadlines](#).

- \* Students who apply after the August 1st deadline will be processed for classes that begin September 8, 2015 and later.
- \*\* Based on class availability.

Applications are accepted online and at all campuses through close of business on the deadline date. When the application deadline date falls on a holiday or weekend the deadline will be close of business on the next business day. All documents required for acceptance must have been received prior to the Application Deadline.

Students are encouraged to apply several months prior to the start of classes to ensure class availability and processing of financial aid.

#### 9TH GRADE LEVEL

- Minimum high school GPA 3.75 in core classes as calculated by the college
- SAT combined score of 1500 or minimum ACT composite score of 33. Applicants also must be exempted from Learning Support by meeting or exceeding the minimum SAT Verbal/Critical

Reading score of 480 and SAT Mathematics score of 440, or applicants must meet or exceed the minimum ACT English score of 20 and ACT Mathematics score of 18.

#### **10TH GRADE LEVEL**

- Minimum high school GPA 3.5 in core classes as calculated by the college
- SAT combined score of 1250 or minimum ACT composite score of 27. Applicants also must be exempted from Learning Support by meeting or exceeding the minimum SAT Verbal/Critical Reading score of 480 and SAT Mathematics score of 440, or applicants must meet or exceed the minimum ACT English score of 20 and ACT Mathematics score of 18.

#### **11TH & 12TH GRADE LEVEL**

- Minimum high school GPA 3.0 in core classes as calculated by the college
- SAT combined score of 970 or minimum ACT composite score of 20. Applicants also must be exempted from Learning Support by meeting or exceeding the minimum SAT Verbal/Critical Reading score of 480 and SAT Mathematics score of 440, or applicants must meet or exceed the minimum ACT English score of 20 and ACT Mathematics score of 18.

#### **Steps to Enrollment**

**Step 1** Complete a GHC admissions application

**Step 2** Request that official high school transcripts be sent to GHC

**Step 3** Request official SAT or ACT scores sent to GHC\*

**Step 4** Complete MOWR consent form found under Admissions Forms

**Step 5** Applicants who seek to be classified as in-state for tuition purposes, will be required to provide validation of residency and [lawful presence](#) in both the State of Georgia and the United States

**Step 6** Have your health care provider complete the GHC Certificate of Immunization Form

**Step 7** Online MOWR application submitted electronically through [www.gafutures.org](http://www.gafutures.org)

**Step 8** Contact a GHC MOWR advisor to address questions and concerns

#### Deadline information:

Allow ample time for receipt and processing of all documents. Processing time varies based on number of applicants and time of year. Please note the deadline for applying for the Dual Enrollment Honors Program for entry Fall 2017 is January 13th, 2017.

**Dual Enrollment** provides an opportunity for high school juniors and seniors to get a head start on college. Students take college classes in lieu of high school classes and earn both high school and college credit simultaneously. This program is designed for academically accelerated students and can also be referred to as Move on When Ready.

- Minimum 3.0 GPA as recalculated by KSU, in courses used to satisfy the 17 College-Preparatory Curriculum (CPC) requirements in English, Mathematics, Natural Science, Social Science and Foreign Language (see Staying on Course link below)
  - SAT

Old SAT (taken prior to March 2016)  
1100 SAT (Critical Reading and Math scores combined)  
SAT Critical Reading score no lower than 530  
SAT Math score no lower than 530

-or-

New SAT (taken March 2016 or later)  
SAT Reading test score no lower than 29  
SAT Math section score no lower than 560

Minimum SAT Total Score:

*All redesigned SAT scores (taken March 2016 or later) will be converted to the pre-March 2016 SAT equivalent. The total score requirement for the Dual Enrollment Honors Program is based on the converted scores:*

- All students must begin the program in Kennesaw State's fall semester. Students must have completed high school curricular requirements to be classified as a junior or senior by the first day of Kennesaw State's fall semester, and must be on track to complete a College-Prep diploma. Students must also be age 15 or older by the first day of Kennesaw State's fall semester.
- Students that are over the age of 15 but under the age of 16 by the first day of class must submit the Dual Enrollment Honors Program Acknowledgement Form for Minors. Please find the PDF of the form in the Application Checklist below.

All students must begin the program in Kennesaw State's fall semester. Students must have completed high school curricular requirements to be classified as a junior or senior by the first day of Kennesaw State's fall semester, and must be on track to complete a College-Prep diploma. Students must also be age 15 or older by the first day of Kennesaw State's fall semester.

- Once you have submitted your student participation agreement form to the Admissions Office and qualify for Move On When Ready (MOWR), you will receive information about submitting your online application using a MOWR application fee waiver. If you do not qualify for MOWR, submit your [online application](#) and \$40 application fee. All applications and supporting documents must be submitted by the appropriate posted deadline for your desired semester of entry.
  
- Submit an official copy of your high school transcript electronically or in a sealed envelope. Home educated students must submit a Home Educated Applicant Portfolio. Please do not submit personal achievement awards or pictures, as no documents will be returned.
  
- Submit official SAT or ACT scores electronically from the testing agency.

- Submit official transcripts from all colleges, universities or schools attended (if applicable).
  
- Students that are over the age of 15 but under the age of 16 by the first day of class must submit the [Dual Enrollment Honors Program Acknowledgement Form](#) for Minors.
  
- Home-schooled students seeking Dual Enrollment admission must submit their [portfolio](#) documents and application by the posted deadline.

The Academy provides a unique early entrance to college opportunity in a fully immersed university setting for students who are looking to accelerate their education while learning and actively participating in an academically enriched environment.

### **Deadlines**

- We are accepting applications for Spring 2017 for current high school freshmen, sophomores, and juniors through October.
- Fall 2017 Priority Deadline: **March 1, 2017**
- Fall 2017 Final Deadline: **June 1, 2017**

All students who are interested in attending The Academy must first apply. Below are the steps to a successful application.

### **Step 1: Make sure you meet the minimum admissions criteria.**

- 3.5 unweighted, academic high school GPA
- and 1 of the 4 following minimum test scores\*
- (1) 1750 Composite SAT\*\* score OR 26 Composite ACT score
- (2) 650 SAT Critical Reading\*\* score OR 28 ACT English score
- (3) 650 SAT Math\*\* score OR 28 ACT Math score
- (4) 600 SAT Writing\*\* score OR 26 ACT Writing score
- If you do not have a high school GPA (entering 9th grade with no high school GPA established), you must meet 2 of the 4 test score requirements

\*Note: University minimum scores must be met in all areas (SAT 430 Critical Reading/ACT 17 English and SAT 410 Math/ACT 17 Math)

\*\*The score requirements here are for the old SAT. UWG will convert scores from the new SAT to the equivalent score on the old SAT for admission purposes; the converted score must meet the minimums outline above. You can check your score conversion here: [Convert your scores!](#)

Students who are currently enrolled in Dual Enrollment at UWG will be admitted based on their UWG performance. Students must have a minimum 3.2 UWG GPA and a minimum of 15 earned credit hours. Those students will receive an invitation to join the Academy and do not have to apply.

**Step 2: If you have not yet taken the SAT or ACT, sign up to do so.** We have [ACT Planning](#) and [SAT Planning](#) information available for you.

**Step 3: Fill out and submit a UWG application, available at [UWG Admissions](#).** On your application, you should select that you are applying to UWG as Dual Enrolled student

**Step 4 (or at any time!): Ask questions!** You can [email us](#), or review our list of [Frequently Asked Questions](#).

**Step 5: Accept your invitation to join the Academy!** All students who apply to dual enroll at UWG who meet or exceed the Advanced Academy's entrance criteria will be invited to join the Academy.

We also work very well with home school applicants and encourage home school students to apply to the Advanced Academy. You will complete the regular UWG application through [UWG Admissions](#), including any supplemental materials required for home school applicants. You should indicate on your application that you are applying to UWG as a home school student and that you are applying for Dual Enrollment.
