All students wishing to have minimum day for the 2025-2026 school year MUST have an application on file by the due date AND sign the Minimum Day ledger in the Counseling Office indicating that the application form has been submitted.

Seniors who participate in Dual Enrollment and/or Work Based Learning courses are eligible for Minimum Day on a <u>limited basis</u>, but this must be approved by the <u>High School Scheduler</u> (See your counselor if this applies to you.)

High School seniors (4th year cohort students) may qualify for minimum day according to the following provisions:

1. Students must have earned 17 credits to have Senior status by May 23, 2025.

2. Students must have passed or be enrolled in the specified courses for high school graduation recorded on the transcript audit, MYAP Progress Tab, and the Senior Letter requirement page.

3. Students must have participated in an **advisement conference** with the school counselor to discuss important topics/opportunities such as, but not limited to Dual Enrollment, Work-Based Learning, the importance of rigorous courses including full time student and admission requirement topics, Academic, Fine Arts, CTAE or World Language course pathways and pathway completion information, HOPE eligibility, etc.

4. Students may be released for one (1) class period (90-minute)/block per day for 1st and/or 2nd semesters.

5. If you currently play a sport at school or are planning to play in the next year, you must meet with your schools Athletic Director as **Minimum Day can impact Athletic Eligibility.**

- 6. Students must request either a.m. or p.m. Minimum Day.
- Circle: A.M. P.M. No Preference (regarding A.M. or P.M.) 7. Minimum day will NOT be granted when:
 - a scheduling conflict occurs with a course needed for graduation
 - courses cannot be rearranged in the student's schedule
