The district has partnered with Kennesaw State University in the Paulding Degree Advancement Program (PDAP). 57 participants have started the first cohort pursuing degrees in math, science and special education. Classes began this week and the district celebrated with a signing celebration for the paras.

<u>Academies Live!</u> took place on January 11th at 6:30pm. The event presented information about the Hiram High School Academy of Computer Science; the South Paulding High School Academy of Engineering & Technology; and Paulding County High School Academy of Science, Research & Medicine.

The Monthly Financial update was presented for review. The next Quarterly Financial update will be in February.

The district celebrated the opening of the Burnt Hickory Elementary School addition with a ribbon cutting ceremony on January 10th. The addition includes 24,000 square feet with 20 instructional units.

The district Spelling Bee will be January 24th at Hiram High School.

Dobbins MS Resolution—Doug Carey reviewed the revision of the FY2022 Application for Dobbins Middle School Facility. The resolution will be presented for approval at the January 23rd Board Meeting.

RFP 24-231006 Construction Management-at-Risk Services Northside ES—Mr. Carey presented the overview of the addition to Northside ES to include 30,000 square feet with 20 new instructional units. The project will also include an enclosed corridor to the existing gymnasium and addition parking. The RFP will be presented for approval at the January 23rd Board Meeting.

RFP 24-231027 Fire Alarm Replacement—Award Request for Proposal to Cooperative Choice LLC dba EMC Security, Suwanee, Georgia. This award will be through completion to replace the fire alarm systems at Dallas ES, Dugan ES, Hutchens ES, Ragsdale ES and Scoggins MS. Contract will be for \$665,420. The RFP will be presented for approval at the January 23rd Board Meeting.

RFP 22-211203 Lawn Care Maintenance—Renew Request For Proposal (RFP) 22-211203 Lawn Care Maintenance to Brightview Landscape, Inc., Atlanta, Georgia. This award will be for the one-year period beginning March 2024 through February 2025. This award is the second of five potential one-year renewals for purchases based on District needs and subject to budget limitations. FY24 working budget_of \$498,617 (includes a 5% contract price increase). The RFP will be presented for approval at the January 23rd Board Meeting.


